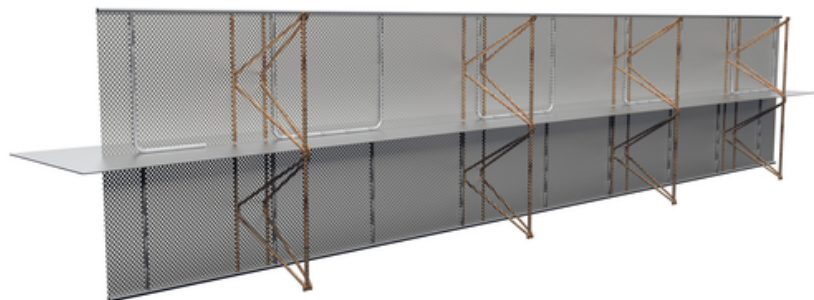

## Basis

All dimensions and information in this data sheet reflect the results of the laboratory tests that have been carried out. Possible country-specific deviations are not taken into account here.

## Lifetime

The useful life of buildings is designed for 50 years, and so are the products that are installed. However, this can be shortened by external influences. The expected lifetime of our products depends to a large extent on the installation location (e.g. buried installation, damp environment, offshore, etc.). In addition, there are external influences such as exposure to chemical influences (e.g. acids, aggressive media, aqueous solutions, industrial waste water, oils, etc.) and ambient temperatures / operating temperatures. Ultimately, no generally valid statement can be made about the guaranteed service life of our MASTERTEC products, as this depends on many parameters (use, environmental influences, installation requirements, safety regulations, etc.). To ensure safe operation, we recommend continuous testing of the product, as part of an operating and maintenance manual to be prepared by the customer in accordance with the safety requirements.
